

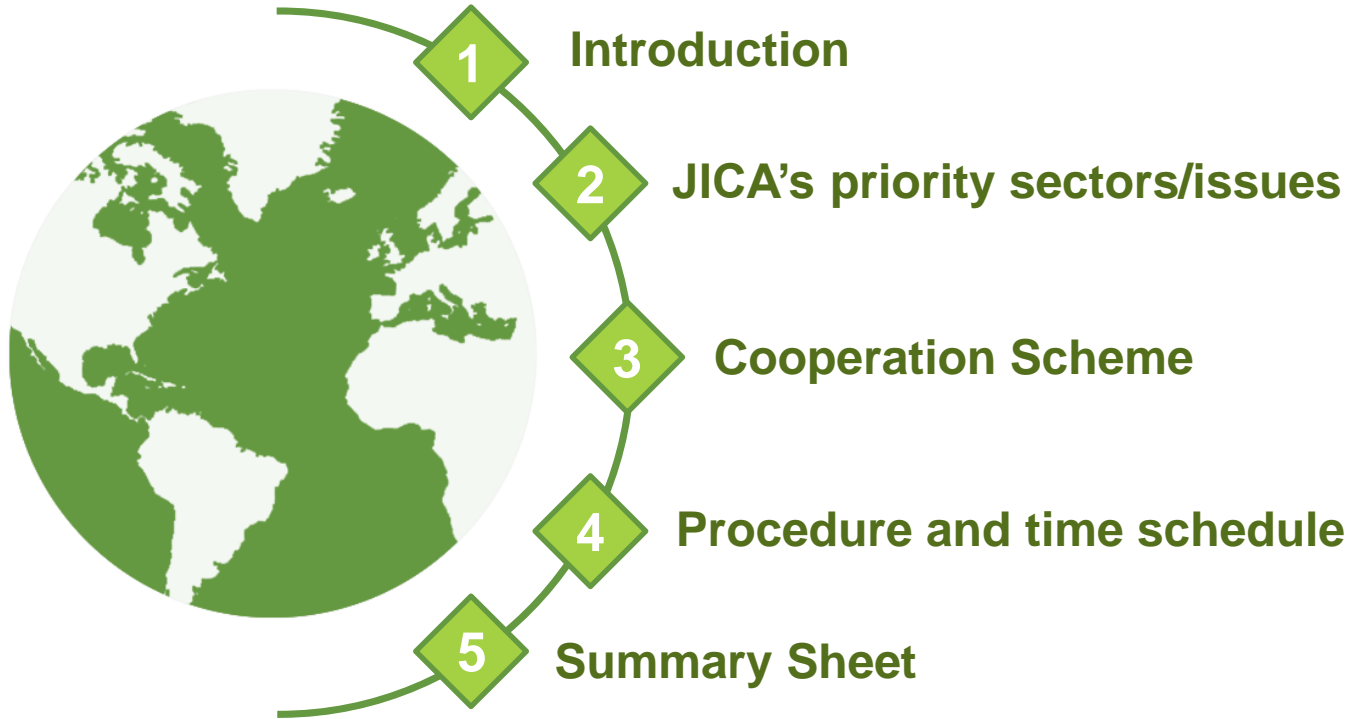

Thai counterpart:

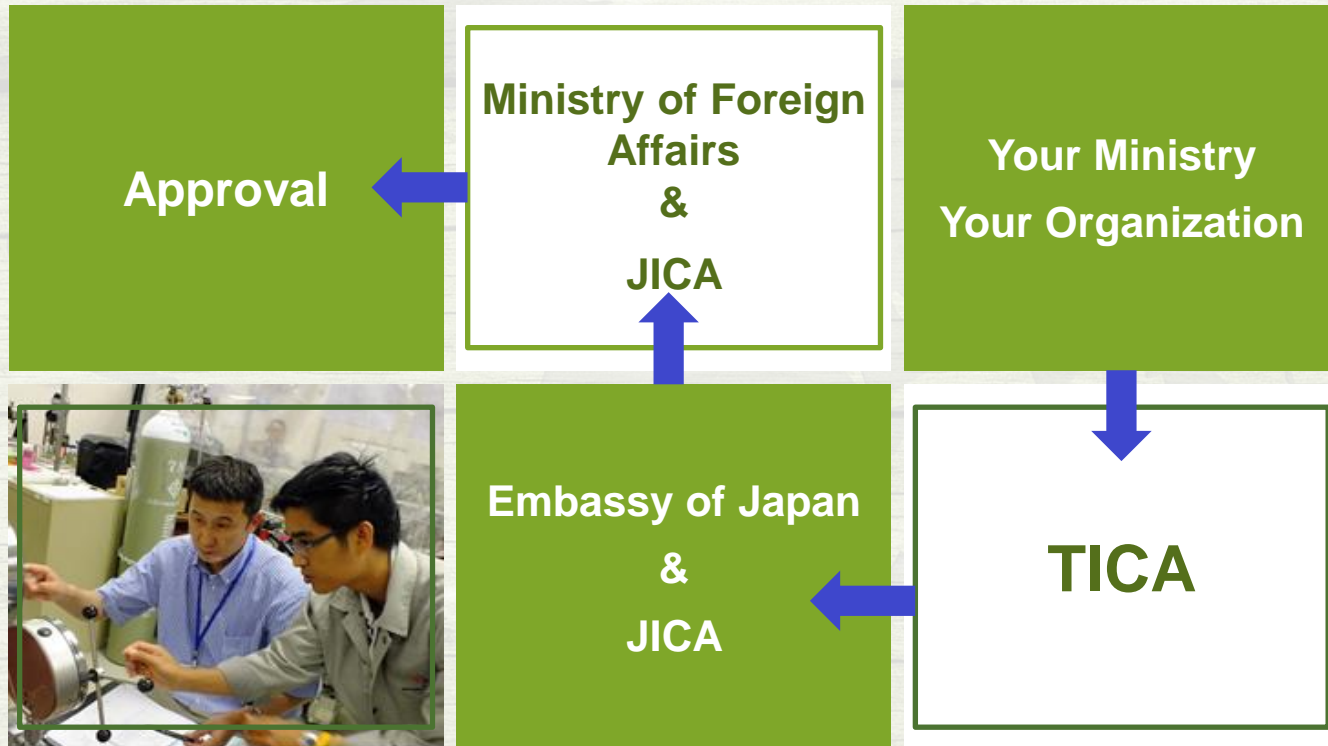
- Thailand International Cooperation Agency

Promoting a “Free and Open Indo-Pacific (FOIP)”



- Addressed by Japan at the 6th Tokyo International Conference on African Development (TICAD VI) in Kenya (Aug. 2016)

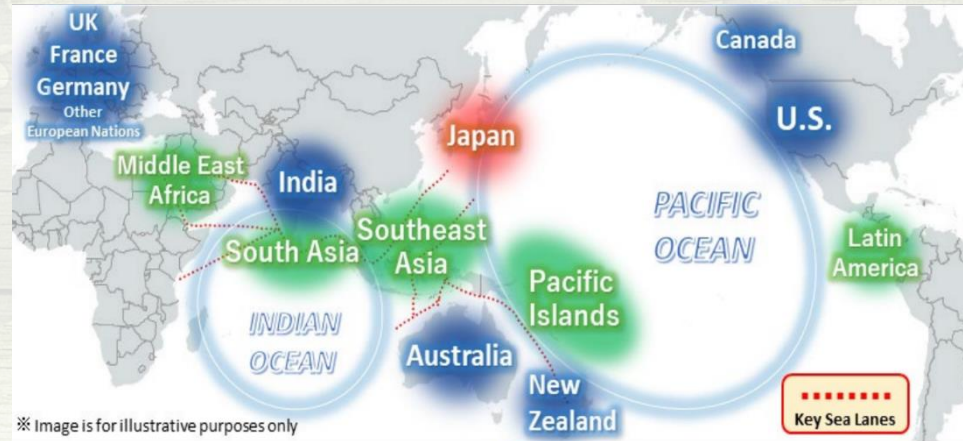
CONCEPT:

- To foster regional stability and prosperity by improving **connectivity** between Asia and Africa through a Free and **Open Indo-Pacific** region.
- Realizing the stable and autonomous development of this region is crucial for the stability and prosperity of the world.
- FOIP has its goal to facilitate **free and vigorous economic activities** throughout the region and aims to realize prosperity for the entire region.

Promoting a “Free and Open Indo-Pacific (FOIP)”

3 PILLARS OF FOIP:

- Promotion and establishment of the rule of law, freedom of navigation, free trade
- Pursuit of economic prosperity (e.g. improving connectivity)
- Commitment to peace and stability





“ASEAN Outlook on the Indo-Pacific (AOIP)”



- ASEAN’s response to the emerging geostrategic shift of major power relations.
- Focusing on ASEAN-centricity, openness, inclusiveness (incl. China), transparency, peace and cooperation.

- Cultural co-existence

JICA's Development Cooperation Scheme

Technical Cooperation Project (TCP)

- Dispatch of Japanese expert(s)
- Training in Japan for the counterpart personnel(s)
- Project for 3~5 years with PDM to achieve the purpose

Technical Cooperation for Development Planning (TCDP)

- Aiming policy proposal (incl. small-scale model project)
- Japanese expert(s) + Training in Japan
- 2~3 years

Individual Expert (IE)

- Policy advisor
- (or several experts in one team)

JICA's Development Cooperation Scheme

Country-Focused Training (CFT)

- Training in Japan
- Cost to be shared by your ministry/organization

In-country Training (ICT)

- Training in Thailand for by Japanese expert.
(not necessarily recommended.)

Third Country Training Program (TCTP)

- Training in Thailand for other countries led by your ministry/ organization (cost to be paid by JICA &TICA)
- For CLMV, ASEAN and Africa etc.
